$$y = (9x^2 - 2)(3x + 1)$$

- (ii) Consider the demand function  $q = 500 - 10p$ . Compute the price elasticity of demand when  $p = 30$ . 4

- (iii) Given the total cost (C) function of a firm as follows

$$C = 10000 + 100Q - 10Q^2 + \frac{1}{3}Q^3$$

Find the level of output at which marginal cost is equal to average variable cost. 4

- (b) (i) A consumer has a following utility function

$$U = f(Q) = aQ^b, \text{ where } a > 0; b < 1$$

Show that the utility function display diminishing marginal utility. 4

- (ii) Given the consumption function  $C = C(Y) = 100 + 0.6Y$ , where  $Y$  is income. Find the marginal propensity to consume (mpc) and marginal propensity to save (mps). 3

- (iii) A firm has the following total revenue (TR) and total cost (TC) functions :

$$TR = 1200Q - 2Q^2$$

$$TC = Q^3 - 61.25Q^2 + 1528.5Q + 2000$$

Calculate the profit maximizing output and the maximum profit. 4

6. (a) (i) Evaluate : 3

$$\int 8e^{2x+3} dx$$

- (ii) Derive the total cost function from the given marginal cost function :

$$MC = 2x^2 - 3\sqrt{x} + 4$$

when the total fixed cost is 200. 4

- (iii) Find out the point elasticity of demand from the following marginal revenue function :

$$MR = 20 - 0.2Q, \text{ when } Q = 5 \quad 4$$

- (iii) Find the consumer surplus from the following demand function when market price ( $P$ ) is 12 : 4

$$Q = \sqrt{60 - 2P}$$

$$Q_d = 14 - 3P$$
